

GULLIVER'S TRAVELS BY JONATHAN SWIFT

Gulliver's Travels is a **satirical novel** by **Jonathan Swift**, featuring **Lemuel Gulliver's** voyages to fantastical lands: **Lilliput**, **Brobdingnag**, **Laputa**, and **Houyhnhnm Land**. Written in prose and divided into four parts, the novel critiques human nature, society, and politics, using **exaggeration** to highlight human folly, **symbolism** to represent pride and reason, and **irony** to expose the absurdity of societal customs.

This module focuses specifically on **Part I – A Voyage to Lilliput**, covering the **main characters, setting, synopsis, themes, conflicts, point of view, moral lessons, and important passages** from this part only.

Main Characters

- **Lemuel Gulliver** – Ship's surgeon and **protagonist**; becomes a giant in Lilliput
- **The Lilliputians** – Tiny people, about **six inches tall**; **proud, petty, and politically divided**
- **Emperor of Lilliput** – Ruler who **tests Gulliver** and represents **authority and politics**
- **Flimnap** – **Treasurer and court official**; involved in political rivalries and plots
- **The Blefuscudians** – People of Lilliput's **rival island**, representing **opposing political views and conflicts**.

Setting

Gulliver's Travels Part I is set on **Lilliput** and **Blefuscu**, fictional islands inhabited by tiny people. The story takes place in **royal palaces, Lilliputian cities, and the surrounding countryside**.

Synopsis

Gulliver's Travels Part I begins with **Lemuel Gulliver**, a ship's surgeon, being shipwrecked and waking up on Lilliput, an island of tiny people about six inches tall. The **Lilliputians**, amazed by his enormous size, tie him down to prevent his escape.

In the resolution, Gulliver leaves Lilliput, reflecting on the absurdity of pride, petty quarrels, and rigid social issues, while the story humorously shows the folly of human behavior.

Themes

- **Pride and Vanity** – The Lilliputians’ obsession with rules, appearances, and **small disputes** highlights their **arrogance** and **petty behavior**.
- **Politics and Power** – Conflicts between **Lilliput** and **Blefuscu**, along with court rivalries involving the **Emperor** and **Flimnap**, create unnecessary tension.
- **Perspective and Relativity** – **Gulliver’s** giant size contrasts with the tiny **Lilliputians**, showing how viewpoint affects understanding.

Conflict

1. Character vs. Character

- **Gulliver vs. Lilliputians** – Gulliver navigates the **Lilliputians’** strict rules, court politics, and demands.

2. Character vs. Self

- **Gulliver** struggles to **adapt** to **Lilliputian customs** while reflecting on **human pride** and **folly**.

3. Character vs. Society

- **Gulliver vs. Lilliputian Society** – Gulliver faces a **rigid, petty society** that focuses on **trivial disputes** and **absurd rules**.

Point of View (POV)

Gulliver’s Travels Part I is told from a **first-person perspective**. Gulliver, the narrator, recounts his shipwreck, his capture by the Lilliputians, and his experiences in their society, sharing his thoughts, observations, and reactions to their customs, politics, and petty disputes.

Moral of *Gulliver’s Travels* (Part 1: A Voyage to Lilliput)

- “Of so little weight are the greatest services to princes when put into the balance with a refusal to gratify their passions.” – *Gulliver, Part I, Chapter V (on the value of service)*

Gulliver’s Travels is a **timeless satire** that combines **adventure**, **humor**, and **moral lessons**, offering insights into **human pride**, **politics**, and **folly** through Gulliver’s encounters with strange societies.

THE ADVENTURES OF HUCKLEBERRY FINN BY MARK TWAIN

The Adventures of Huckleberry Finn by Mark Twain follows Huck Finn's travels along the Mississippi River. Although Huck first appears in *The Adventures of Tom Sawyer*, this novel is not a direct sequel but focuses on his own story, exploring his moral growth and reflections on freedom and society. Written in prose, it captures 19th-century American speech and culture, using satire, irony, symbolism, and vernacular to give characters authentic voices.

Main Characters

- **Huckleberry "Huck" Finn** – Protagonist and narrator; **adventurous, independent**, and struggles with moral dilemmas
- **Jim** – A runaway slave owned by Miss Watson; **compassionate, loyal**, and **values freedom** and **friendship**
- **Tom Sawyer** – Huck's friend; **imaginative, adventurous**, and **clever**; helps plan Jim's escape
- **Pap Finn** – Huck's **abusive, alcoholic father**; **selfish**, and **racist**; sparks Huck's escape
- **The Duke and the King** – Conmen; **deceitful, greedy**, and **chaotic**

Setting

The novel is set along the **Mississippi River** in **19th-century America**. Key locations include the **river**, where travel and freedom unfold; **towns along the shore**, which reveal society's rules; and **cabins** and **farms**, where **personal struggles** and **conflicts** take place. The setting feels **dynamic** and **unpredictable**, reflecting **adventure, danger**, and the search for **independence**.

Synopsis

Huckleberry "Huck" Finn runs away from his abusive father, **Pap Finn**, and meets **Jim**, a runaway slave, on the Mississippi River, where they travel seeking freedom.

Themes
